It also permits caregivers to focus on their court-related business and reduces disruptions in the courtroom. While CourtCare is dedicated to protecting children from the stress of legal proceedings, they can't do it alone. Polk County CourtCare has been able to continue providing services, but Marion County CourtCare had to close their doors in July 2019 due to a lack of continued funding and the demolition of the YMCA facility that housed the program.
