It also permits caregivers to focus on their court-related business and reduces disruptions in the courtroom. While Court and Community Care is dedicated to protecting children from the stress of legal proceedings, they can't do it alone. Marion County Court and Community Care had to close their doors in July 2019 due to a lack of continued funding and the demolition of the YMCA facility that housed the program. We are excited that it will be reopening at the Salem Withnell Family YMCA soon!
